1. Data privacy overview

General information

The following information provides an overview of what happens to your personal data when you visit our website. Personal data is any data that can be used to identify you personally. Detailed data protection information can be found in our privacy policy below this text

Data collection on our website

Who is responsible for data collection on this website?

How do we collect your data?

We collect certain data when you send this data to us. This can include data such as that entered into a contact form.

What do we use your data for?

3. Data collection on our website

Cookies

Comment function on this website

When using the comment function on this site, we store your comment along with the time the comment was created, your email address and, if you are not posting anonymously, your chosen username.

IP address storage

Our comment function also stores the IP address of the user who wrote the comment. Following comments

Data processing (customer and contract data)

WordPress Stats

This function allows the ad target groups created with Google Analytics Remarketing to be linked with the cross-device features of Google AdWords and Google DoubleClick. This allows relevant, personalised advertising to be shown to the user that is based upon their previous usage and browsing activity on a device (e.g. mobile phone) and on other devices used by the user (e.g. tablet or PC).

If you have granted the necessary consent, Google will link your web and app browser history to your Google account. This allows the same personalised advertising messages to be displayed on every device on which you are logged into your Google account.

To support this function, Google Analytics collects google-authenticated IDs of users that are temporarily linked with our Google Analytics data in order to define and create target groups for cross-device advertising.

Collation of the collected data in your Google account is done exclusively on the basis of your consent given to Google and which you are able to withdraw (Article 6(1)(a) GDPR). Google AdWords and Google Conversion Tracking

This website uses Google AdWords. AdWords is an online advertising program of Google Ireland Limited, Gordon House, Barrow Street, Dublin 4, Ireland.

As part of Google AdWords, we use so-called conversion tracking. When you click on an advert displayed by Google, a conversion tracking cookie is set. Cookies are small text files that your web browser creates on your computer. These cookies remain valid for 30 days and are not used to personally identify the user.

If the user visits particular pages on this website and the cookie has not yet expired, both we and Google can identify that the user has clicked on the advert and was forwarded to that page.

Google reCAPTCHA

We use "Google reCAPTCHA" (hereinafter known as "reCAPTCHA") on our websites. The provider is Google Ireland Limited, Gordon House, Barrow Street, Dublin 4, Ireland ("Google").

The reCAPTCHA feature is intended to check whether data being entered into our website (e.g. in a contact form) is being done by a human or by an automated computer program. The reCAPTCHA analysis

The reCAPTCHA analysis runs entirely in the background. Website visitors are not informed that this analysis is taking place.

The data processing is based upon Article 6(1)(f) GDPR. The website operator has a legitimate interest in protecting their website against automated infiltration attempts and snam

Facebook Pixel

Our website uses the user action pixel from Facebook for conversion monitoring, Facebook Inc., 1601 S. California Ave, Palo Alto, CA 94304, USA ("Facebook"). This allows the actions of page visitors to be tracked after clicking on a Facebook advert displayed on the provider's website. This enables the effectiveness of Facebook adverts to be statistically assessed for market research purposes and for future campaigns to be optimised.

The data collected is made available anonymously to us as operator of this site. We are not able to draw any conclusions about your identity. Data entered into the newsletter registration form is processed only with your consent (Article 6(1)(a) GDPR). You may at any time withdraw your consent for the storage of your data, email address and its use for sending the newsletter. This can be done, for example, using the "unsubscribe" link in the newsletter itself. The legality of all data processing carried out up to the point at which the withdrawal of consent is received remains unaffected.



The data you provide to us for the purpose of receiving the newsletter will be stored as long as you continue to receive the newsletter. The data will be deleted when you unsubscribe. Data that has been stored by us for other purposes (e.g. email address for the membership area) remain unaffected by this.

YouTube

Our website uses plugins from YouTube, operated by Google. The provider of the website is Google Ireland Limited, Gordon House, Barrow Street, Dublin 4, Ireland.
